

GENERAL TERMS AND CONDITIONS OF PARTICIPATION

3. Place and date of activity.

“Panairi Kosova 1999-2009. 10th Jubilee Edition” will take place in Pristina, Kosovo from September 23rd until 28th, 2009 and will be open from 9.00 am to 7 pm each day for visitors and from 8.30 am to 7.30 pm for exhibitors.

The administration of the Fair reserves the right to alter the date and the time of the Exhibition in case of exceptional circumstances beyond the control of the organizer. In this case Alhoo shpk accepts no liability and cannot be cited for any damages or compensation.

4. Application

To participate in the fair, exhibitors enter into a written contract with Alhoo to lease space (below “The Application”). Pursuant to Applications received, Alhoo will assign the exhibition space.

Applications must be received, without fail **by 30 June 2009**. The minimum rentable area is 12 sqm. (3x4m)

5. Allocation of stands

By signing the application, the Exhibitor undertakes to accept whatever area may be assigned to him even if the area dimensions are different from those requested.

Alhoo may, if required by the layout of the fair, assign max up to 10% more or less area than that applied for (only in very special needs).

6. Confirmation and sub-letting of spaces

Allocations of space will be confirmed from 15 July 2009 and are valid only for the exhibitors named thereon. No sub-letting or transfer, whether entire or partial, even if free of charge is admissible.

7. Payment.

For any rendered service Alhoo will issue an invoice to the exhibitor. If the exhibitor does not pay the invoice/s by the latest on the 1st September 2009, he will not be able to exhibit.

8. Stand rental charges

Position:

- aisle position € 25,00 per sq.m.
- two open sides € 40,00 per sq.m.
- end of aisle (3 open sides) €60,00 per sq.m.

Modular stand erection (to be added to cost of area)
Basic € 50,00 per sq.m.
Complete € 75,00 per sq.m.
Special customized design can be agreed with clients

The above rates apply to the entire area occupied. The plan and measurements of each stand are the basis of payment for space allocated.

9. Deposit

Applications should be accompanied by
€ 250,00 for registration fee (entry fee)
Eur 15 + VAT for each sq.m of rented space
Eur 20+VAT for each sqm of pre-erected stand
Applications which do not enclose the entry fee (250 Eur), deposit of 15 + VAT Eur/sqm for area and 20+VAT Eur/sqm for pre-erected stand will not be processed.
These applications will be reimbursed in full should the application be rejected.

The entry fee includes:

- listing in Official Catalogue (excluding advertisement)
- listing on Official Web Site
- one complimentary copy of Official Catalogue
- Exhibitors' passes for employees of the Company
- technical assistance during the Exhibition and in setting up and dismantling stands
- general security services for buildings, and fire-fighting precautions

10. Withdrawing

In case of cancellation by the Exhibitor after the 30^h June, entry fee and deposit are forfeited. If the booked area cannot be reassigned to another applicant, the original would be Exhibitor is liable for the whole sum involved with no right of appeal.

11. Real guarantee of payment.

It has to be accepted with this article that the administrators of the Fair has the authorisation of keeping the goods in the Fair as a guarantee until the payment of the participation in this Fair is fulfilled.

12. Damages caused in your stand.

Any damage caused in the stand because of your carelessness has to be paid in full plus 20% of the penalty.

13. The guard service.

Alhoo will take care of the goods during the day and nights, when the Fair is closed. Alhoo will not be responsible of any damage or theft of the exhibited goods in the stands while the Fair is open.

14. Cleaning.

During setting-up and dismantling, cleaning is the responsibility of the individual Exhibitor.
During the Exhibition Alhoo will take care of the cleaning of the stands and other objects in the Fair.

15. Advertisement

Alhoo will arrange all the advertisement and publicity in the media (newspapers, radio, Tv) and through the Internet before and during the Fair. While the Fair is open the administration will take care of the voice centre of the Fair and publishing every material in the Internet.

16. Official catalogues.

The administrators will take care of editing and printing the official catalogue. For this reasons the

participants MUST fill the formulary within the 30 June, in order to avoid any mistake in publishing the catalogue.

17. The paid services.

With additional payment clients can have following services:

- a) - Transport and custom service
- b) - Insurance of your goods
- c) - Hostess and translators
- d) - Photography and video
- e) - Telephone and internet service during the Fair.
- f) - Lease of conference and meeting rooms

18. General obligations.

Participants are forbidden to:

- Pull their goods out before the Fair is over
- Repair the stands during the opening hours of the Fair
- Attract the people using loud tone or loud noises
- Put materials and goods outside the stand assigned for them
- Make propaganda or judge social –politic institutions with the aim of criticising or offending
- Make publicity on behalf of third parts.

19. Particular point.

Not respecting the above points of this regulation causes the cancellation of the contract and closing of the stand immediately and without reimbursement.

20. Erection & Setting-up of Stands

20.1 Each exhibitor shall submit the set-up planned for his exhibition area, including lighting installations, to Alhoo Sh.p.k for its approval. Fittings shall not be higher than 3 (three) metres from the ground. Alhoo Sh.p.k may change said limit for special exhibition fittings, informing the exhibitor thereof. The Company, at its sole discretion, may authorize in writing exceptions to the height limit for single exhibitors, without the same exception applying to the other exhibitors.

20.2 In the areas granted no exhibitor can install furniture and objects that could deprive the other exhibitors of light, or annoy or damage them.

20.3 Alhoo Sh.p.k reserves the right to intervene with its staff and to charge the corresponding expenses to the exhibitor, in order to remove or modify those installations that could be detrimental to, or damage the look of the pavilion, or that could be a nuisance for other exhibitors and the public, or that have in any case been carried out without Alhoo Sh.p.k's approval or in non-compliance with the provisions of the following clause.

20.4 In any case the exhibitor remains the only liable party for anything concerning the setting up of the areas granted to him and for the damage that could arise, both towards Alhoo Sh.p.k and third parties; the exhibitor must also indemnify the Company against any possible claim for damage by any party whatsoever.

20.5 For setting up the stand, the exhibitor shall strictly comply with all the rules set forth in the corresponding form, attached to the participation application, to be duly signed in all its parts, and concerning fire prevention, safety of setting up materials and systems in compliance with prevailing standards.

20.6 The exhibitor must hand over a copy of all the technical documentation as per previous paragraph to Alhoo Sh.p.k before the set-up materials are transported into the exhibition zone, and keep the originals at his stand.

20.7 Entrance of vehicles with the engine on inside the pavilions is strictly forbidden, unless authorized by Alhoo Sh.p.k as an exception.

In that case the applicant shall guarantee that the exhaust gas will be emitted outside through piping or other suitable technical means.

20.8 The exhibitor may not either change the stands, floors, columns, or hang frames on walls, force locks open, make holes or paint.

20.9 In the event of changes, alterations or damage to the stands or the objects made available by Alhoo Sh.p.k, and ascertained by its technical staff, the exhibitor will be debited with the corresponding restoration or replacement costs, without prejudice to any further damages.

20.10 It is forbidden to use circular saws, milling machines or other equipment inside the pavilions without the necessary suction systems for the dust and sawdust produced by working the materials used to set up the stands.

20.11 Spaces that without justified reason:

a. have not been suitably set up and have no sign, are not occupied with exhibition products, and are not free from packaging or other materials that will not be used for the exhibition;

b. have been left unattended or obviously neglected during the exhibition;

can be considered by Alhoo Sh.p.k., at its sole discretion, to be abandoned and therefore the latter can freely make arrangements for them.

In that case the exhibitor, without prejudice to the payment of the stand area fee, shall pay a penalty equal to twice as much as the participation fee, without prejudice to any further damages.

20.12 After the exhibition opens, no goods entry or exit will be allowed, apart from exceptional cases to be previously authorized by Alhoo Sh.p.k.

21. Claiming.

A possible claim has to be directed to Alhoo Sh.p.k in the written form.
